**A Business Plan is required.** The Business Plan identifies your business opportunity, its market and financial potential. It provides a mechanism to objectively examine the feasibility of the business idea, also the market, financial, technical and personal feasibility.

**Basic research is required.** Your action to gain information to help achieve business objectives or clarify points. To seek information about potential clients, supplies, competitors and develop personal and business contacts or useful informational networks for the business.

**Evidence of business study has been undertaken.** Necessary to strengthen your understanding of business principles and business success depends on important factors of planned business and an emphasis on finance management and bookkeeping.

**Consider the position of your business** in its industry and the industry position in the general economy.

**Maximum** loan is up to \$20,000.

**Security is required.** All security is to be valued and insured at 100% in value of the loan amount requested. MWDI lend on the current value of Motor Vehicles: on Real Estate: Guarantor security: Chattels or most forms of negotiable securities.

**MWDI Interest rate is currently** 9% and Finance rate will vary on the amount borrowed with terms and conditions. Schedule of calculated monthly repayments are provided.

**MWDI require the Business Application Form** to be fully completed with attachments and returned before the Directors assessment is undertaken.

**MWDI request that all requirements indicated are** forwarded with the Business Application Form with evidence of identification be submitted.
